The SSI's mission is to enhance end-to-end transparency, sustainability, and environmental, social and governance performance across the solar supply chain. Businesses actively involved in the solar value chain can apply to join the SSI and get certified against the SSI Standards.

1. General Guidelines

The words SSI, SOLAR STEWARDSHIP INITIATIVE and the logos included in this document are trademarks of the SSI. They may only be used with the explicit consent of the SSI and subject to the conditions set by the SSI. All other use of those signs will be considered a trademark infringement. The SSI reserves all rights in that regard.

There are different types of claims and logos depending on membership categories and participation in the SSI assurance process (please refer to the SSI membership categories for more information).

Currently only membership and certified member site claims can be made. **No product-related** claims are allowed, such as where a product comes from, that a product is produced in a certain way, or other origin or provenance claims. Product claims will become possible once the Traceability Standard has been developed.


The Solar Stewardship Initiative name, abbreviation and logos must never be used in a way that could:

- → Suggest or imply SSI membership of an entity that is not an SSI Member, or part of an SSI Member.
- → Suggest or imply SSI certification before it has been achieved.
- → Suggest or imply a larger scope of SSI certification than an SSI Member has actually achieved.
- → Suggest or imply that certain materials, or products are SSI-certified.
- → Use SSI membership or certification to support vague or misleading sustainability claims not included in this Guide.
- → The names of the SSI logos may not be translated into other languages without also retaining the English version/s for reference.

2.1 Membership Claims

The SSI will not associate or may disassociate based on the following criteria:

SSI Members in any category can use the SSI Member logo to indicate in their communications that they are members of SSI. Becoming a member of SSI signifies a commitment to SSI Principles, it does not guarantee that any member's site practices or supply chains are in compliance with the SSI ESG Standard.

The membership claim may only be displayed on company websites, flyers and other marketing materials, corporate material (e.g. annual reports, sustainability reports), invoices, letter heads and other contractual documents, and it may not be displayed on products.

SSI Members are only considered certified once they have undergone an independent assessment and achieved certification in line with the SSI's Assurance Manual, at which time they can make the certified site member claims.

SSI Members may also use the associated written claims alongside the member logo.

2.2 Certified Member Site Claims

Once a site of an SSI Member has completed an assessment and achieved certification against the SSI ESG Standard as confirmed by the SSI Secretariat, the Member may use the certified member site logo and written claim for the **specific site or sites1**.

The certified member site claim can be displayed on company websites, flyers and other marketing materials, corporate material (e.g. annual reports, sustainability reports), invoices, letter heads and other contractual documents, as long as there is no ambiguity as to which site or sites is associated with the certified member site claim. The certified member site claim may not be displayed on products.

Certification does not guarantee that an entire company's supply chain is free from human and labour rights abuses, environmental degradation or governance issues.¹

2.3 Approved Assessment Body

Only assessment bodies that have been approved by the SSI to conduct assessments against the SSI Standard and are listed on the SSI website with an approval status may use the assessment body logo and written claim. The approved assessment body claim can be displayed on company websites, flyers and other marketing materials, corporate material (e.g. annual reports, sustainability reports), invoices, letter heads and other contractual documents.

3. Approval for use of the SSI Claims

To use any of the SSI Claims, an approval is required from the SSI, unless otherwise specified in this document, in order to ensure use complies with the relevant standards. For a claim to be approved, please submit requests, including proposed text and logo use and placement by e-mail to SSI Secretariat at secretariat@solarstewardshipinitiative.org

4. Raising a complaint about misuse

Non-compliance with the terms of this Guide can lead to SSI withdrawing an SSI Member's right to make a claim and use the SSI logos. It may also result in suspension or termination of SSI membership. Legal recourse may be pursued in the case of non-Members.

Any inappropriate or potentially misleading or fraudulent claims or representations about SSI by either Members or non-Members should be immediately reported by sending an email to the SSI Secretariat at secretariat@solarstewardshipinitiative.org The SSI Complaints mechanism may also be used for this purpose.

The preliminary due diligence screening is intended to assess whether the applicant is applying in good faith to contribute to the SSI mission, with the expectation that they are seeking to improve
